Sendo assim, as Partes, de comum acordo, resolvem, celebrar o presente **TERCEIRO ADITIVO AO CONTRATO DE FORNECIMENTO E DEMAIS CONTRATOS ACESSÓRIOS** (“Aditivo”), que se regerá pelas seguintes cláusulas e condições, a saber:

1. DA ALTERAÇÃO DO PRAZO CONTRATUAL DO CONTRATO DE FORNECIMENTO

1.1. Tendo em vista negociação havida entre as Partes, resta aditado o Contrato de Fornecimento para refletir o novo prazo de vigência que passa a ser respeitado, a partir da assinatura deste instrumento: DS
MPDS

1.1.1. O item 9 do preâmbulo do Contrato de Fornecimento passa a vigorar com a seguinte redação:

“9. PRAZO CONTRATUAL: 12 (doze) meses - Prazo de Denúncia: 30 dias”

1.1.2. O prazo de vigência definido no Contrato de Fornecimento será respeitado em todos os demais CONTRATOS.

2. DAS DISPOSIÇÕES GERAIS

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, ASSOCIAÇÃO DE PROTEÇÃO À MATERNIDADE E À INFÂNCIA DE MUTUÍPE – IMAPS (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
